4. First-aid measures

6. Accidental release measures

Methods and materials for containment and cleaning up

Refer to attached safety data sheets and/or instructions for use. Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. This product is miscible in water. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. Should not be released into the environment. Prevent entry into waterways, sewers, basements or confined areas. Stop leak if you can do so without risk. Use clean non-sparking tools to collect absorbed material.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. Clean up in accordance with all applicable regulations. Following product recovery, flush area with water. Small Dry Spills: With clean shovel place material into clean, dry container and cover loosely; move containers from spill area. Clean surface thoroughly to remove residual contamination. This material and its container must be disposed of as hazardous waste.

7. Handling and storage

Precautions for safe handling

Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Keep away from heat. Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Keep away from clothing and other combustible materials. Take any precaution to avoid mixing with combustibles. Avoid breathing dust. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Do not taste or swallow. When using, do not eat, drink or smoke. Pregnant or breastfeeding women must not handle this product. Should be handled in closed systems, if possible. Wear appropriate personal protective equipment. Wash hands thoroughly after handling. Avoid release to the environment. Observe good industrial hygiene practices.
