[Prevention]

**5. FIRE-FIGHTING MEASURES**

<b>Prevention of secondary hazards:</b>	Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid all contact!
