**Precautionary Statement(s):**  
[Prevention]

Keep away from heat, sparks, open flames and hot surfaces. – No smoking. Keep container tightly closed. Keep only in original container. Ground and bond container and receiving equipment. Use explosion-proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe dusts or mists. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.

[Response]

If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower.
