### 4. First-aid measures

**Methods and materials for containment and cleaning up**

Stop leak if you can do so without risk. Prevent entry into waterways, sewers, basements or confined areas. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect dust using a vacuum cleaner equipped with HEPA filter. Sweep up or gather material and place in appropriate container for disposal. This product is miscible in water. Clean up in accordance with all applicable regulations.

Large Spills: Wet down with water and dike for later disposal. After removal flush contaminated area thoroughly with water. Absorb in vermiculite, dry sand or earth and place into containers. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

**7. Handling and storage**

**Precautions for safe handling**
