6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:	Absorb spilled material in a suitable absorbent (e.g. rag, dry sand, earth, saw-dust). Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing.
