

## Ammonium Sulfate Solution (4M) (Catalog# TBS5038)

### Description

Ammonium sulfate is widely used for precipitation and fractionation of proteins as well as for the crystallization of proteins and protein-nucleic acid complexes.

Ammonium sulfate is also utilized in hydrophobic interaction chromatography and antibody purification. Ammonium sulfate acts by pulling water molecules away from the non-polar units of proteins. The decrease in available water molecules increases the surface tension and enhances hydrophobic interactions, thus allowing the protein to precipitate from a solution or bind to a hydrophobic column.

**Storage:** Supplied as 4M Ammonium Sulfate Solution, 500mL. Store at room temperature.

Note: The reagent is supplied as a ready-to-use, clear, colorless liquid. If crystals are observed in the bottle, this may be due to the temperature of the solution falling below 25 °C during shipping or storage. Warm the solution to 30–37 °C and gently mix to redissolve the crystals. Allow the solution to cool to room temperature prior to use.
