Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water. Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Specific target organ toxicity - repeated exposure Not classified. The perchlorate ion competes with iodide in the mechanism that governs uptake into the thyroid gland for growth hormone production. This effect is routinely countered by ensuring sufficient dietary intake of iodine, as perchlorate does not accumulate in the body. Studies on workers in plants where perchlorates are manufactured have shown no thyroid abnormalities; various clinical studies are ongoing. Perchlorates occur naturally in trace amounts in the environment, and are not classified as carcinogenic.
