**[Prevention]**

Keep away from heat, sparks, open flames and hot surfaces. – No smoking. Keep container tightly closed. Ground and bond container and receiving equipment. Use explosion-proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe mist, vapors or spray. Use only outdoors or in a well-ventilated area. Do not eat, drink or smoke when using this product. Wash hands and face thoroughly after handling. Wear respiratory protection. Wear protective gloves, protective clothing, eye protection.

**[Response]**

If swallowed: Immediately call a poison center or doctor. Rinse mouth. If on skin: Wash with plenty of soap and water. Call a poison center or doctor if you feel unwell.
