### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Oxygen or artificial respiration if needed.

**Methods and materials for containment and cleaning up**

Refer to attached safety data sheets and/or instructions for use. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). This product is miscible in water. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. Should not be released into the environment. Stop the flow of material, if this is without risk.

Large Spills: Wet down with water and dike for later disposal. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal.

Never return spills to original containers for re-use. This material and its container must be disposed of as hazardous waste. For waste disposal, see section 13 of the SDS.
