4. First-aid measures

Inhalation	If dust from the material is inhaled, remove the affected person immediately to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Methods and materials for containment and cleaning up

Eliminate ignition sources including sources of electrical, static or frictional sparks. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. This product is miscible in water. Should not be released into the environment. Stop leak if you can do so without risk. Use clean non-sparking tools to collect absorbed material.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Do not get water inside container. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. Clean up in accordance with all applicable regulations. Following product recovery, flush area with water.

Small Spills: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Clean surface thoroughly to remove residual contamination. This material and its container must be disposed of as hazardous waste.

Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Wear appropriate protective equipment and clothing during clean-up. Small Dry Spills: With clean shovel place material into clean, dry container and cover loosely; move containers from spill area.

7. Handling and storage

Precautions for safe handling

Keep away from heat. Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Keep away from clothing and other combustible materials. Take any precaution to avoid mixing with combustibles. Avoid breathing dust. Avoid contact with eyes, skin, and clothing. Do not taste or swallow. When using, do not eat, drink or smoke. Wear appropriate personal protective equipment. Wash hands thoroughly after handling. Observe good industrial hygiene practices.

Conditions for safe storage, including any incompatibilities

Keep away from heat. Store in a cool, dry place out of direct sunlight. Store in original tightly closed container. Store in a well-ventilated place. Do not store near combustible materials. Store away from incompatible materials (see Section 10 of the SDS).
