Steam should not be generated unnecessarily. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Avoid shock and friction. Wash hands and face before breaks and immediately after handling the product. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid all contact!

<b>Storage conditions:</b>	Keep container tightly closed. Store in a cool and dark place. Store locked up. Be sure not to give the container unexpected impacts, such as falling down or falling off. Store away from incompatible materials such as oxidizing agents. Light-sensitive
