6. ACCIDENTAL RELEASE MEASURES

Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
Environmental precautions:	Prevent product from entering drains.
Methods and materials for containment and cleaning up:	Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container.
