A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.

<b>Storage conditions:</b>	Keep container tightly closed. Store in a cool and dark place. Store under inert gas. Store away from incompatible materials such as oxidizing agents. Light-sensitive Air-sensitive
