4. First-aid measures

Inhalation

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Avoid inhalation of dust. Use a NIOSH/MSHA approved respirator if there is a risk of exposure to dust/fume at levels exceeding the exposure limits. Methods and materials for containment and cleaning up

Stop the flow of material, if this is without risk. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air).

Large Spills: Wet down with water and dike for later disposal. The product is immiscible with water and will spread on the water surface. Collect dust using a vacuum cleaner equipped with HEPA filter. Avoid the generation of dusts during clean-up. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Avoid discharge into drains, water courses or onto the ground.

Precautions for safe handling
