**4. FIRST AID MEASURES****First aid measures****General Advice:**

**Skin Contact:**

## 6. ACCIDENTAL RELEASE MEASURES

### Personal precautions, protective equipment and emergency procedures

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Remove all sources of ignition.
