## 4. First-aid measures

### Description of first aid measures

<b>General advice</b>	Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.
<b>Inhalation</b>	Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. **Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure.

## 5. Fire-fighting measures

<b>Suitable Extinguishing Media</b> <b>Large Fire</b>	Dry chemical. Carbon dioxide (CO <sub>2</sub> ). water spray. Alcohol resistant foam. CAUTION: Use of water spray when fighting fire may be inefficient.

Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up**    Take precautionary measures against static discharges. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labeled containers.
